

**BETADINE ® SOCCER SPRINT
CONTEST TERMS & CONDITIONS OF ENTRY**

(ONLY OPEN TO LEGAL RESIDENTS OF SINGAPORE)

Mundipharma Pte. Limited (UEN: 200400553C) ("Mundipharma", "we", "us") maintains a web site at <http://sg.betadine.com> ("Web Site") and is responsible for this contest and promotion.

A. General Terms

1. You can play the Betadine ® Soccer Sprint game ("Game") via the Web Site subject to the Web Site's [Terms of Use](#) and [Privacy](#) Policy.
2. If you wish to enter the contest around the Game, you must agree to the contest's specific terms and conditions, which are set out below ("T&Cs").
3. To register as a participant of the contest, you must log into your Facebook account.
4. You will be responsible for any cost you incur when you access the Web Site, enter the contest or collect any prize.
5. If the contest is interfered with in any way or the contest is not capable of being conducted as we reasonably anticipate for any reason, then Mundipharma has the absolute discretion, to the fullest extent permitted by law, to modify, suspend, terminate or cancel the contest at any time, without prior notice to you.
6. The T&Cs will be governed by the laws of Singapore and you agree to submit to the exclusive jurisdiction of the courts of Singapore.

B. Qualifying Participants

1. The contest is only open to lawful residents of Singapore who are aged thirteen (13) years and above.
2. Employees of Mundipharma, their advertising and promotion agencies and any employee's immediate family members and/or persons living in the same household of each employee are not eligible to enter the contest. In these T&Cs, "immediate family members" means partner/spouse, parents, step-parents, siblings, step-siblings, children and step-children (whether natural or adopted).
3. If there is a dispute as to the identity or qualification of a participant under these T&Cs, we reserve the absolute right to determine the dispute and disqualify any persons we consider are ineligible.

C. Contest Entries & Winners

1. The contest will run from 10 February 2017 to 31 March 2017.
2. Participants may only enter the contest once, but each entry will be updated and the score increased every time a participant plays the Game.

3. All entries must be received by Mundipharma before 23:59 hours on 31 March 2017.
4. Mundipharma reserves the right to disqualify all entries that do not meet the T&Cs. These include entries submitted with unauthorised, fraudulent, invalid or incorrect information.
5. This contest involves playing a game of skill; chance plays no part in determining the overall winners of the contest.
6. The winners, who must be eligible participants under the T&Cs, will be determined on the basis of their scores in the Game.
7. There will be only one grand prize winner. The grand prize will be awarded to the participant with the highest score in the Game overall and where there are more than two participants with the highest score, the participant to reach the highest score who was first in time, before 23:59 on 31 March 2017, will prevail.

D. Prizes

1. Mundipharma's decisions about the application of the T&Cs and the determination of the award of all prizes are final and binding on all participants. No queries, challenges or appeals about Mundipharma's decisions may be made or considered.
2. Contest winners will be announced on the [Web Site](#) and prize notification emails will be sent on or before 7 April 2017. The grand prize winner will also be notified separately by email and must reply by return email on or before 10 April 2017 to confirm the grand prize.
3. The grand prize winner shall receive (a) two x return economy air tickets travelling from Singapore to Manchester UK, (b) two x stadium tickets to see a Manchester City home match and (c) two nights' accommodation for two persons in Manchester + other great prizes. All airport taxes, government levies and incidental costs of the air tickets are included in the grand prize. All other costs and expenses related to the grand prize will be at the grand prize winner's personal expense.
4. In the event that the participant selected as the grand prize winner has not fully complied with the T&Cs, he or she will be disqualified from the contest and no longer able to claim the grand prize and Mundipharma, will select the next highest scoring participant as the grand prize winner who will be subject to the T&Cs.

E. Prize Conditions

1. To collect prizes, all notified winners (including the grand prize winner) must produce original proof of their identity as well as their status as a lawful resident of Singapore, to Mundipharma's satisfaction. The grand prize winner must also produce a printed copy of the grand prize notification email;
2. Prizes are non-transferable, cannot be redeemed for cash in any way and may be subject to availability.

3. Value of the prizes may vary and Mundipharma reserves the right to replace any prize with items of similar value without prior notice.
4. If any prize is not collected by 24 April 2017, Mundipharma reserves the right to deal with any unclaimed prizes as we see fit.

If the grand prize winner is under 18 years old, he or she will only be eligible to claim the grand prize if he or she will be accompanied to Manchester by a parent or legal guardian. Once the air tickets are booked, no date changes are permitted and the grand prize winner's failure to travel after booking means the grand prize will be forfeited with no compensation, substituted travel dates or ticket replacement. Travel will always be subject to the carrying airline's conditions of carriage.
